

## Information on the processing of personal data

In accordance with Regulation (EU) 2016/679 of the European Parliament and of the Council on 27 April 2016 on the protection of individuals with regard to processing of personal data and on the free movement of such data and on cancellation of Directive 95/46/EC (General Data Protection Regulation) and in accordance with Act No. 110/2019 Coll., on the processing of personal data and on the amendment of certain laws as amended (hereinafter referred to as "GDPR") we are obliged to inform you as a data subject (hereinafter referred to as the "Client") about the method of processing of your personal data in Bioptická laboratoř s.r.o. (hereinafter only "Administrator").

The Provider and the Client have entered into an Agreement on the provision of laboratory examination services, which consists in the operation of the online ordering system, whose purpose is to enable clients to create orders for laboratory examinations. Within this legal relationship, the Provider will process personal data of the client in accordance with Act No. 110/2019 Coll., on the processing of personal data as amended.

### ***Implementation of the contractual relationship:***

This processing is necessary for the fulfillment of the Contract, which the Client is a party to. The processing of the client's personal data is performed on the basis of statutory authorization referred to in Article 6 (1) of the GDPR. Based on this authorization, the Administrator is not obliged to request from the Client their consent to the processing of personal data.

### ***The range of personal data processed in the online ordering system:***

- name and surname,
- birth number, date of birth (for foreigners)
- delivery (invoicing) address,
- email address,
- telephone

### ***Purpose of processing the provided data:***

This data is processed in order to create an order for a laboratory examination.

### ***The period for which the provided personal data will be stored:***

The storage period is determined by law.

### ***Personal data Administrator:***

- Bioptická laboratoř s.r.o., Mikulášské nám. 628/4, 326 00 Plzeň for the purpose of carrying out a laboratory examination.

### ***Your rights regarding the protection of your personal data:***

- According to Article 15 of the GDPR, the data subject has the right of access to personal data relating to them, the right to request from the Administrator under Article 16 of the GDPR correction of inaccurate personal data concerning them, in accordance with Article 17 of the GDPR the right to delete personal data concerning them. The data subject has the right to have the Administrator restrict the processing of the personal data of the data subject in the cases listed in Article 18 of the GDPR. The data subject has the right to require the Administrator to inform them of the recipients of personal data in accordance with Article 19 of the GDPR. The Administrator does not process personal data automatically, the right to data portability under Article 20 of the GDPR therefore does not apply.
- Under Article 21 of the GDPR, the data subject has the right to object at any time processing of personal data concerning them in the case of necessary processing for the performance of a task carried out in the public interest or in exercise of official authority pursuant to Article 6 (1) (e) of the GDPR.
- It is not possible to demand the deletion of personal data which the provider of health services are obliged to collect on the basis of a legal obligation (obligation imposed by law).
